

ATHLETE'S CONSENT & USE OF ADAMS FORM

Doping Control Related Data

I am being asked to acknowledge that I know and adhere to the IPC's Anti-Doping Code and that I undertake to abide by its provisions. I am being asked to read this form to ensure that I am aware that my Doping Control related data will be used in anti-doping programs for detection, deterrence and prevention of doping. Signing this form will indicate that I have been so informed and that I give my express consent to such processing.

I understand and agree that:

- My Doping Control related data will be used in the context of the anti-doping programs and as described in more detail in the "Athlete Information Notice";
- My Doping Control related data is all data related to the process including Therapeutic Use Exemptions, Whereabouts information, test distribution planning, sample collection and handling, laboratory analysis, results management, hearings and appeals;
- The IPC will use a web-based data management system ADAMS (Anti- Doping Administration & Management System), designed by the World Anti-Doping Agency (WADA) to assist WADA in its role as a central clearing house;
- IPC will use ADAMS to process and manage my Doping Control related data, and disclose it only to authorized recipients (for example, designated national anti-doping organizations, international or national sporting federations, major event organizers, and WADA). WADA-accredited laboratories will also use ADAMS to process my laboratory test results, but shall only have access to de-identified, key-coded data that will not disclose my identity; and
- My Doping Control related data will be stored in ADAMS for a minimum period of eight (8) years being the period within which an action may be commenced in the ICP Anti-Doping Code (article 17: Statute of Limitations).

WHEREABOUTS SUBMISSIONS TO ADAMS

I understand that the IPC has included me in its Registered Testing Pool (RTP) and thus will act as my Custodian Organization for my profile in ADAMS.

I will be in particular responsible for ensuring that the information provided regarding my Whereabouts is accurate and up-to-date. I am aware that failure to provide and/or update my Whereabouts information may constitute an Anti- Doping Rule Violation, whether is it intentional or unintentional.

I will be provided with login details in order to submit my data to ADAMS. I will be responsible for keeping my password confidential and for ensuring that all information that I enter into the system or that is entered on my behalf by a third party is accurate and up-to-date.

CONSENT FOR RESEARCH

During the doping control test, I can decide to agree or not for my sample to be used for anti-doping research purposes when all analyses have been completed and my sample would otherwise be discarded. It may be used by any WADA- accredited laboratory for anti-doping research of any type, provided that it can no longer be identified as my sample. I understand that by declining my consent for research there are no implications.

RELEASE

I hereby release WADA, as well as the IPC, from all claims, demands, liabilities, damages, costs and expenses that I may have arising in connection with the processing of my Doping Control related data through ADAMS.

WITHDRAWAL OF CONSENT

I understand that I may at any time revoke my consent to the processing of my Doping Control related data. I also understand that such withdrawal of consent will be construed as a refusal to participate in the anti-doping procedures mandated by the World Anti-Doping Code and the IPC Anti-Doping Code and could exclude me from further participation in organized sporting events and may result in disciplinary or other sanctions being imposed upon me, such as disqualification from competitions in which I am scheduled to participate or the invalidations of results from prior competitions.
